Keynote Address

H. Westley Clark, M.D., J.D., M.P.H., CAS, FASAM; Dr. Clark is currently the Dean's Executive Professor of Public Health at Santa Clara University in Santa Clara California. He is formerly the Director of the Center for Substance Abuse Treatment, Substance Abuse and Mental Health Services Administration, U.S. Department of Health and Human Service, where he led the agency's national effort to provide effective and accessible treatment to all Americans with addictive disorders. Dr. Clark was also the former chief of the Associated Substance Abuse Programs at the U.S. Department of Veterans Affairs Medical Center in San Francisco, California and a former associate clinical professor, Department of Psychiatry, University of California at San Francisco (UCSF). Dr. Clark served as a senior program consultant to the Robert Wood Johnson, Substance Abuse Policy Program, a co-investigator on a number of the National Institute on Drug Abuse-funded research grants. He worked for Senator Edward Kennedy as a health counsel on the US Senate Committee of Labor and Human Resources.

He has received numerous awards for his contributions to the field of substance abuse treatment, including a 2008 President Rank of Distinguished Executive Award and a 2003 President Rank of Meritorious Executive Award in the Senior Executive Service. He was awarded the 2008 John P. McGovern Award from the American Society of Addiction Medicine for his contributions toward increased understanding of the relationship between addiction and society. Other awards include the U.S. Department of Health and Human Services Secretary's Award for Distinguished Service; Vernelle Fox Award from the California Society of Addiction Medicine for excellence in Addiction Medicine, Education and Public Service, 2000.

Dr. Clark received a B.A. in Chemistry from Wayne State University in Detroit, Michigan; he holds a Medical Degree and a Master's in Public Health from the University of Michigan, Ann Arbor; where he completed a Psychiatric Residency at University Hospital, Neuropsychiatric Institute. He obtained his Juris Doctorate from Harvard University Law School and completed a two-year Substance Abuse Fellowship at the DVAMC-SF. Dr. Clark received his board certification from the American Board of Psychiatry and Neurology in Psychiatry and sub-specialty certifications in Addiction Psychiatry. Dr. Clark is licensed to practice medicine in California, Maryland, Massachusetts and Michigan. He is also a member of the Washington, D.C., Bar.

Jessica Schmoll, Licensed Professional Counselor and Certified Professional Counselor Supervisor, MARR, Inc.; Jessica began her academic career at the University of North Carolina at Chapel Hill, and later obtained a master's degree in Business/Counseling from Northeastern University in Boston. After spending several years in corporate human resource management, Jessica returned to school and completed her master's degree in Rehabilitation Counseling from Georgia State University. She began her relationship with MARR, Inc. soon after, and began work as an Assessment Counselor and, over time, held the positions of Family Counselor, Primary Counselor, and Residential Manager at the Women's Recovery Center. During a three-year period away from MARR, Jessica worked with individuals in private practice and worked in hospital inpatient and outpatient settings treating addiction, mental illness, and eating disorders. Since her return to MARR in March of 2013, she has served as Director of the Women's Recovery Center, where she is passionate about helping women recover from complex addiction in a gender-specific setting. She regularly facilitates trainings in the community, providing continuing education credits for clinicians regarding women and addiction. She continues to work part-time in a private practice setting as well.

Samuel Moose, Commissioner of the Department of Health and Human Services, Mille Lacs Band of Ojibwe; Samuel Moose was re-appointed to his third term as Commissioner of Health and Human Services for the Mille Lacs Band of Ojibwe, a position that he previously held from 2001 – 2009. In this role, Mr. Moose oversees the Band's Department of Health and Human Services, developing strategies, programs and policies that govern the health care and human service system. Which includes three clinic sites in central Minnesota, public health, family services & child protection, behavioral health and community support services. In addition, Mr. Moose currently serves on the National Indian Health Board, as the Midwest region (Bemidji Area) representative, Moose remains an active member within the traditional framework of his community in District II of Mille Lacs Band of Ojibwe. Moose graduated from University of Minnesota - Duluth with his Master Degree in 2013, and received his undergraduate degree in Community Health from the University of Minnesota – Duluth.

Rashida Fisher, Consultant; Rashida has over a decade of professional experience in addiction and cooccurring mental health treatment delivery, supervision, and program development. Rashida specializes in Culturally Responsive Care, Trauma Informed Service Delivery, and Integrated Dual Disorder Treatment. Rashida is a board member for Minnesota Recovery Connections (MRC). Rashida provides consultation services for staff and program development. She speaks at a variety of conferences nationally. She hosts a Public Affairs radio show on 89.9 KMOJ FM. Rashida is currently a doctoral student.

Jeff Schiff, M.D., M.B.A., Medical Director for Minnesota Health Care Programs - Minnesota Department of Human Services; Dr. Schiff is the Medical Director for Minnesota Health Care Programs at the Minnesota Department of Human Services. He has served as medical director since June 2006.

His work focuses on the development and implementation of evidence based benefit policy and the advancement of improved care delivery models. Specific areas of interest include the development of policy to enhance the role of primary care; the use of collaborative intrastate processes to implement

quality improvements across the healthcare system; and the use of claims and clinical data to report and improve health outcomes. The Health Services Advisory Council, a physician based policy advisory body for the development and implementation of evidence based policy, is organized through this division. His team leads, sponsors or collaborates on work on opioid use and abuse; perinatal outcomes, quality measures, social determinants of risk, and autism at this time.

Dr. Schiff is the current chair of the Medicaid Medical Directors network. He has served as the cochair of the Agency for Healthcare Research and Quality (AHRQ) committee that was charged with the identification of initial core set of children's healthcare quality measures for Medicaid across the country. Dr. Schiff has served as president of the Minnesota Chapter of the American Academy of Pediatrics. He practices clinical pediatric emergency medicine at Children's Hospital in St. Paul.

Honorable Senator Chris A. Eaton, Minnesota Senate District 40; Christine Ann "Chris" Eaton represents Senate District 40, which includes the cities of Brooklyn Center and Brooklyn Park in Hennepin County, in the Twin Cities metropolitan area. She won a special election in October, 2011 and was re-elected in November 2012 to a new four year term. Eaton is a registered nurse and a member of the Minnesota Nurses Association. She is currently working in the Special Needs Basic Care Dept. at Mental Health Resources, Inc.

She previously worked as a nurse in the Ramsey County Mental Health Initiative, and as a human services technician at the Anoka Treatment Center. Lucinda E. Jesson Commissioner, Minnesota Department of Human Services; Lucinda E. Jesson is commissioner of the Minnesota Department of Human Services. DHS is the state's largest agency, serving well over 1 million people with an annual budget of \$11 billion and more than 6,500 employees throughout the state. The department administers a broad range of services, including health care, economic assistance, mental health and substance abuse prevention and treatment, child welfare services, and services for the elderly and people with disabilities. Prior to her current position, Jackie has served as the aging services specialist with the Minnesota Board on Aging. In that capacity, she managed continuing care programs and elder services programs for American Indian tribes in Minnesota, specifically Wisdom Steps, Preventative Health for American Indian Elders.

Ms. Dionne has worked for the State of MN both DHS and MDH for nine years. Prior to working for the State of MN, she has worked over 20 years with Minneapolis American Indian non-profits; American Indian Community Development, Little Earth of United Tribes and Baby Space to name a few.

She grew up in Minneapolis, graduated from the Minneapolis Public School and received her undergraduate degree from the University of MN in Early Childhood Education. She is the daughter of Rachel and Simon Dionne, both from the Turtle Mountain Chippewa Tribe in Belcourt ND. She has one daughter, Amanda Dionne and one grandson, Robert Benjamin-Curtis.

She is also the Author of three books: *Robbed of a Childhood, Raped by the System; From Hell to Heaven Journal*; and *An Incomplete Story of a Whole Person*.

She is a powerful woman of God who believes we can empower those who many may have deemed less fortunate. "Education is the key to reclaiming your personal power and moving on to greater expectations". Mary was the recipient of the 2010 Spirit of Peace Award, the 2010 Presidential Volunteer Lifetime Achievement Award, the 2010 Governor's Faith Based and Best Practices Initiative Award and the 2008 Jonathan Farmer's Illuq Award.
